
Summer Reading Book Reviews

Cuba Ex-Libris

It is no coincidence that I am reviewing two books about Cuba. I, along with Jennifer Andersen, am helping plan the NSCCAPA Professional Trip to Cuba this fall (see page 5 for more details). Cuba has received a lot of media attention lately. However, *Cuba: 400 Years of Architectural Heritage* by Rachel Carley and Andrea Brizzi, and *The Havana Guide: Modern Architecture, 1925–1965* by Eduardo Luis Rodriguez, are timely because of the unique lessons Cuban architecture and planning can offer.



Cuba: 400 Years of Architectural Heritage by Rachel Carley, photographs by Andrea Brizzi, (Whitney Library of Design Press, Italy, 1997, \$29.95 for soft-cover, ISBN #0-8230-1128-3).

The book starts off with an introduction and explanation of the “roots” of Cuban architecture, and then it provides a wonderfully descriptive and photographic account of all subsequent architectural periods of Cuba’s lush, decadent, tropical and colorful history.


Cuba: 400 Years comprehensively documents the Early Colonial Era (1512–1762); the Late Colonial Era (1762–1898); the Republican Era (1898–1959); and the Revolutionary Era (1959–Present). Especially beautiful are the 300 full-color photographs of Cuba’s fabulous architectural heritage, including many of the places that APA plans to visit in Cuba on our “draft” trip itinerary. Also of interest and importance is a detailed timeline of Cuba’s history, which is more than just a chronology of its architectural history, that covers from 1000 BC—when humans first inhabited the island, up to

1996—when the U. S. Congress passed the Cuba Democratic and Solidarity Act (Helms-Burton), which permitted U.S. Citizens and nationals to sue (in U.S. courts) foreign firms investing in expropriated Cuban property.

The Havana Guide: Modern Architecture, 1925–1965 by Eduardo Luis Rodriguez, translated by Lorna Scott Fox (Princeton Architectural Press, New York, 2000, \$24.95 for soft-cover, ISBN #1-56898-210-0).

This book may be a challenge to find as I’ve been advised by a Cuban art/architecture tour guide friend that it is either “out of print” or that it was perhaps printed in “limited quantities.” So, if you are feeling lucky, I’ve included the ISBN Number to help you search it out (Happy Hunting!). The author, Eduardo Luis Rodriguez, is an architect and the editor-in-chief of “Arquitectura Cuba,” an architectural journal currently published in Cuba. He is also, by design, one of the premier contacts that APA plans to meet on our trip touring Havana’s architecturally-significant neighborhoods and districts.

For those Modernists out there (other than myself), *The Havana Guide* expertly catalogs and features, through the aid of many beautiful color and black/white photos, over 200 structures built between 1925 and 1965, ranging from residences to hotels, churches and government buildings. Even today, these structures and buildings make up the enormous architectural wealth that is the City of Havana. Each neighborhood and district or, as they are referred to in the book, each “territory” of the City corresponds with a specific chapter in the book. Each chapter includes a street map that “pin-points” each structure and building


The one-day conference will be held September 28, 2002, at San Jose State University in the Student Union.



Do We Get the Cities We Deserve?

Seduction of Place reviewed by Diana Painter

Joseph Rykwert, *The Seduction of Place: The History and Future of the City*, First Vintage Edition, March 2002 (originally published 2000)

Anyone who loves cities and loves urban history will want to read this book. Joseph Rykwert, professor emeritus at the University of Pennsylvania, presents an entertaining, broad-ranging and inclusive account of how we, as urbanists and as a society, have gotten to where we are today in the design of cities. Driving forces and underlying motivations are woven together in discussions of such periods of experimentation as the rise of industry, the problem of urban housing in 19th century England, and the concurrent utopian community experiments in America.



The discussion of historical and contemporary trends focuses on the interrelationships of social and economic forces as they come to bear on urban form, primarily in the U.S., Britain, France and Germany. Also examined are some of the same trends and experiments in India, Brazil, and China, among other countries.

Contemporary issues include how postmodernism has affected urban design and the production of architecture; the shortcomings of the New Urbanist movement in creating multi-dimensional urban places; and the problems and effects of globalization on our cities and social fabric.

The most valuable appeal Rykwert makes is to remember that cities are "a willed artifact and a human construct." He reminds us that the fabric of the city "is a tangible representation of that intangible thing, the

society that lives in it—and of its aspirations." And finally that "the success of a city . . . depends on the inherent strength of the fabric and its availability to the social forces that mold the life of its inhabitants." We, as citizens and as designers and planners, are not without the ability to act, and we are not victims of unseen and unknowable forces.

The built form becomes a metaphor for how we see ourselves and how others may see us. In an afterward written in 2002, Rykwert brings home his point that if anyone has any doubt that built form carries metaphoric power, one only has to reflect on the targets of the terrorist attacks of 9/11. How we choose to read the city is undeniably a part of who we are, and this bears re-evaluation.
