NATIONAL LAND USE CONFERENCE: February 5th

Presented by the American Land Alliance and the California Coastal Council, this conference will present a discussion of the need for a new state and federal land policy. Speakers and panelists include congressman Pete McClosky, Assemblywomen Carol Hallett, Assemblyman Robert Naylor, State Senator Daniel Boatwright, and representatives of the Pacific Legal Foundation, the National Parks Advisory Board, the Land Policy Group, the Sagebrush Rebellion, and the American Land Alliance. Topics will include:

- Proposals for return of land use decision making from state and federal agencies to local government.
- 2. Agricultural Preservation: Another Coastal Commission?
- The new federal land use policy of the Reagan administration; legal and planning implications.
- 4. Off-shore oil drilling: The issues beneath the surface.
- Economics of federal land use policies as it affects jobs, housing, and costs to the consumer.
- 6. How do we use 700 million acres of federal land: wilderness or multiple use?
- 7. Regulatory overkill and multiple agency jurisdiction.
