Participatory Planning Turns Conflict into Creativity

# Collaborative Strategies for Managing Environmental Issues

Legal battles over environmental issues are costly and divisive. When communities and land holding companies vie over development rights, or when regional agencies struggle with each other over jurisdictional control, enormous amounts of time and money are spent in an attempt to "win" the conflict. Frequently, however, when environmental issues are resolved through litigation, neither of the interested parties emerge as clear "winners." Relationships are severed and the die becomes cast for future conflict.

Recently, planners have been discovering that collaborative approaches to public participation, inter-sector dialogue, and decision-making can help diverse groups generate mutually beneficial solu-

tions to complex environmental problems, while avoiding unnecessary conflict and its resulting costs. The use of collaborative techniques, such as participatory planning, collaborative decision making, conciliation and mediated negotiation, can result in the successful resolution of seemingly irresolvable controversies.

Long Beach's Coastal and Downtown Shoreline Program, regarded throughout California as an exemplary case of coastal planning, was the result of the active collaboration of development, neighborhood, housing, and environmental advocates. The lack of public controversy in the adoption and certification process was due in large part to the collaboration of all the various

# CCAPA 1985 AWARDS

The California Chapter of the American Planning Association and its eight sections invite members of APA to nominate planning programs, agencies, and individuals for awards that recognize advances in the field of planning.

The Awards Program has three levels: 1) Section level -- nominations of local and regional concern are made to the Section that represents the area to which nominations apply; 2) Chapter level -- winners of first place Section awards are submitted by the Section to the Chapter; in addition, nominations of statewide but not of local or regional concern must be submitted to Sections Award Coordinator for forwarding to Chapter; 3) National level -- outstanding winners of Chapter awards are submitted to APA's national office for consideration under the National Awards Program.

#### AWARD CATEGORIES

- A. Outstanding Planning Awards in two subcategories, not more than one award to be given in each subcategory, and not more than two additional submissions in each subcategory to be awarded honorable mention:

  - To a comprehensive planning program or process of unusually high merit.
     To a specific planning project or ordinance of unusually high merit.
- B. Distinguished Leadership Awards divided into five subcategories, not more than one award to given in each subcategory:
  - 1. To a planner for sustained contribution to the profession over a period of at least 10 years through distinguished practice, teaching, or writing.

    2. To a person who is not a professional planner or an elected official for significant contribution to excellence in
  - public planning.
    To an elected official for significant contribution to excellence in public planning.

  - To a planning firm for outstanding achievement in public or private planning.
  - 5. To a planning agency for outstanding achievement in planning.
- C. Award for Innovation in Infrastructure Planning to a person, group, agency, or firm for achievement and innovation in the financing, assessment, development or other planning-related activities in the area of infrastructure at the local, state, or federal level.
- D. Award for Contribution to Women in Planning to a planner (male or female) who has contributed to the positive image of women in planning. Nominees must have demonstrated significant contributions to the profession, held a management position in planning, and devoted substantial effort to community service. (This corresponds to the Diana Donald Award of the National Awards Program.)
- Distinguished Service Award to an APA member who has made a substantial contribution to the development and objectives of the organization, or to its predecessor, AIP and ASPO, over a long period, such as 15 years. Not more than one award will be given.
- F. Academic Award for Excellence in Planning Education to faculty and students to recognize outstanding work done in planning schools on an individual or collective basis by teacher(s) or student(s). Submission must outline specific project or attainment of specific planning education objectives.
- G. Donald G. Hagman Meritorious Award to the person (APA member or non-member, professional or student) whose work has focused on the subject of equity in Tand-use through planning or writing or law.
- Journalism Awards will honor two newspapers and one journalist for outstanding coverage of city and regional planning and/or environmental concerns: one to a newspaper with a circulation of 100,000 or more and one to a newspaper with a circulation below 100,000,and one to an individual journalist.
- I. Media Award for outstanding coverage of a planning topic to the person, agency, or group originating the most responsible and innovative commentary or documentary in any media besides journalism.

- To be able to receive a Chapter Award, the following requirements must be met: 1) A nominator must be a dues paid member of the California Chapter and National APA. Members may nominate their own work. Section Directors nominate section winners to Chapter.
- 2) All work submitted must have been accomplished for agencies, clients, or schools located in the State of California.
   3) All work submitted for an Outstanding Planning Award, Infrastructure Planning Award, or Journalism Award must have been completed or adopted by December 31, 1984. No resubmissions of same work from previous Section or Chapter awards competition shall be accepted.
- 4) Recipients of Distinguished Leadership Awards, Award for Contribution to Women in Planning, and the Distinguished
- Service Award are ineligible to receive the same award for 5 succeeding years.

  5) Recipients of all other awards are ineligible to receive the same award 2 succeeding years; in the case of Outstanding
- Planning Awards, this restriction applies to program, project, or report, not to its authors or sponsors.

  6) Members of the CCAPA Awards Committee are not eligible to enter or be nominated for awards nor to receive CCAPA awards during their terms of service.
- 7) No more than one entry or nomination for any award category is to be made by any entrant or nominator.

- Evaluation Criteria

  1) ORIGINALITY. Innovative concept or appreciable refinement of existing techniques or procedures.


  - TRANSFERABILITY. Potential application in other areas or to other projects.
     QUALITY. Excellence of thought analysis, writing, graphics, and character of presentation.
     IMPORTANCE. Perceived importance of the project to the study area or of the concept or process to the field of

    6) COMPREHENSIVENESS. Planning principles have been observed, especially in considering a project's effects on other public objectives.

stakeholders in the planning of the local coastal program.

In a neighborhood-based dispute, The Institute for Environmental negotiation in Charlottesville, Virginia helped to mediate negotiations between neighborhood residents and a local moving-van line company to alleviate traffic and parking problems along local streets. As a result of the collaborative negotiation, company and neighborhood representatives were able to work out several solutions to the problems, including a joint initiative to alter county policy regarding the commercial use of local streets.

The collaborative approach to environmental decision-making is not a panacea. But in light of environmental legislation designed

to increase public participation and spread the power to decide and implement regulations across a spectrum of interest groups, including community members, industry officials, and government representatives, planners should learn effective techniques to structure interaction between various stakeholders.

Good managemnt of public spaces can do more to get people downtown to shop and play than large-scale urban design schemes, concludes a newbook, *Managing Downtown Public Spaces*, published by APA. This guide shows how city governments and downtown businesses across the country have joined forces to make public spaces safe, attractive, and lively. In his new book published by APA, author John M. DeGrove looks at how seven states have asserted, for the first time, a state and regional concern in land- and growth-management decisions, an area formerly left to local governments. Land, Growth and Politics is a study of the political dynamics of this "quiet revolution," its impacts, and the prospects for its continuation through the eighties. The book is now available for \$33.95.

Tens of thousands of Americans serve on zoning boards across the country with little or no background in zoning administration. The Zoning Board Manual, a comprehensive look at the powers, duties and responsibilities of the zoning board, is the first national manual on the subject. Author Frederick H. Bair, Jr., has written this guide to help boards exercise those powers assigned to them by law, in the manner provided by the law, so they may perform their proper role of protecting the public interest.
