Bay Area Growth Management SIVED MAY 13 1 ... Initiatives Debated

What is a planner to do when the citizens of his or her community decide to take matters into their own hands via 'Ballot Box' Planning? This timely topic to local planners was explored at Northern Section's workshop on growth management initiatives held on April 23rd at the Walnut Creek City Hall. Twenty-five attending planners heard the perspectives of panelists Jerry Swanson, Chief of Planning of Walnut Creek; Sausalito Planning Director Michael Foley; Tom Cook, a Policy Analyst for the Bay Area Council; and People for Open Space (POS) Executive Director Larry Orman.

Following the consumption of Northern California wine and cheese, the program began with Swanson describing the attempts of Walnut Creek planners to implement its recent traffic control initiative, Measure H. The distinguishing feature of this initiative was the level of detail of the measure, which specifies levels of service for traffic at specific intersections. Clarifying the meaning and intent of its provisions has been a time-consuming task for planners.

Tom Cook expressed the Bay Area Council's concern over growth management initiatives on the impact on housing. The suburbanization of office space has led to a fundamental change in development causing more inter-community traffic problems and a 'housing-jobs' imbalance. A regional perspective is needed to deal with these problems, Cook argued.

Mike Foley next described his experience with many growth management tools while working at several agencies. The several approaches he used included housing allocation systems using 'points,' downzoning

based on carrying capacity, and a specific plan which attempted to preserve Sausalito's 'working waterfront' from regional serving offices.

Larry Orman described his analysis of POS's survey of 45 growth control measures in Northern California as to what it meant for professional planners. The development of job intensive offices on the metropolitan fringe has led to cross-commuting traffic patterns for which the radial system of highways and transit was never designed. The resultant problems from this new pattern gives rise to the use of initiatives.


The issue of how such initiatives affect the role of planners was explored next by the panel with Swanson raising the concern of what is t be the role of planners when citizens assume that role via initiatives. Orman argued that such measures, if they do not become too specific, are effective ways to decide basic land use policy issues and should be welcomed. Foley commented on the problems and limits that planners face in the drafting and interpreting of initiatives, and the process of how such measures spread or become 'regionalized.'

Cook and Orman wrapped up the discussion by pleading for the need of a regional perspective. While Orman said this fundamentally required a plan or vision of "how the region should be structured," Cook argued that the first step is to establish the mechanism, process, or institution to encompass regional level issues.

Agricultural Economic Study Undertaken by San Mateo County

Responding to public concern over rural land use and agricultural protection issues, the San Mateo County Board of Supervisors has called for a study to examine the existing and future viability of agriculture in the County's coastal areas.

The impetus for this study has come from the Board's review of the updated and consolidated General Plan, designed to guide the future development of San Mateo County to the year 2000. The policies of this Plan and previously-adopted County and State planning efforts have strongly promoted the protection of agricultural land from conversion to non-agricultural uses, particularly in the rural coastal areas.

While the study is being conducted, the Board will continue to review the General Plan and will use the information from the study during future evaluation of the County's Local Coastal Program, at which time any recommended policy adjustments could be made.
