

## Northern Section Board Studies Restructuring

The 1400 member Northern Section is the largest in California and is larger than all but the California and Florida State Chapters of APA. Despite this membership strength, participation in Section activities has been very low. In response, the Board is evaluating a change in the Section's structure to involve more of the membership and improve service delivery. Currently the Section, which covers the coastal area from Monterey to the Oregon Border, is organized on a geographical basis with regional liaisons appointed by the Board to develop programs and represent member interests. While the Northern News does a great job of communication with the membership, most programs and events draw less than 5 percent of the Section's members, participation in nominating and voting for officers is abysmal, and Board members burn out quickly.


After a year of study, the Northern Section Board has developed an alternative structure. The Organization Option is based on special interest committees organized into five Commissions, each headed

by a member of the Section's Board. The revised structure would allow members the opportunity to participate in committees of their choice, with each committee responsible for advising the Board on special issues, developing events and educational programs for the membership, and serving as a resource for the Section in areas of special knowledge and interest. Future Section officers and commissioners would be drawn from the ranks of this active membership.



## AICP Exam Prep at Stanford and UC Davis

Study groups have been formed for the next AICP national exam, to be held May 15, 1993 (note that it has changed to Saturday). But it is not too late to attend the five monthly workshops at Stanford or the three workshops at UC Davis Extension.

The Stanford format will be similar to last year, with half day sessions on five Saturdays. Sessions will begin at 10 AM and end by 1:45 PM on January 9, February 6, March 6, April 3 and May 1, 1993. They will be held in the Philosophy Dept., Bldg. 90, Room 91A. The cost is \$25 plus purchase of a manual.

The UC Davis program will cover the same materials but in three full Saturdays, February 20, March 20 and April 17, 1993. Sessions will be

from 9:30 AM to 4:30 PM in the University Faculty Club. The cost is \$100 plus purchase of a manual. Lunch will be provided.

Test takers must purchase the APA Chapter Presidents Council AICP Exam Prep. Manual for \$25 at either session location. The program includes study groups, audio tapes, guest lecturers, and tips from those who passed the test last year.

# CEQA AND GENERAL PLANS: MAKE YOUR OPINIONS KNOWN

Want a chance to influence legislation on CEQA and the General Plan? This is your chance. Bob Odland, Northern Section's Legislative Liaison, is a member of the CCAPA/AEP CEQA Task Force that has been studying possible changes to CEQA. Some of the Task Force's concerns are the increasing length of EIRs, misuse of CEQA by NIMBYs, and the lack of integration of CEQA and General Plan processes. Bob and other planners and attorneys from around the state are working on the Task Force subcommittee that is specifically looking at the relationship of CEQA to the General Plan. A major focus is reducing the number of project-specific EIRs by strengthening the environmental perspective of General Plans.

Northern Section will host a discussion of this important topic on February 25th, at which Bob will discuss the work of the Task Force to date and gather your ideas. He will also explain the CCAPA legislative review process for all planning-related bills and tell you how you can become involved. Watch for more information in the next edition of Northern News.

### The President begins his dialogue...

President-elect Bill Clinton's spokeswoman is quoted as saying "We are building a two-way dialogue with the people of the country..." (Is there a one-way dialogue?) We are reminded of Ross Perot's promise that, if elected, he would use "electronic town meetings" to reach out to the people...

Meanwhile, in town and city halls across the country, planners are already making excellent use of FCC (Federal Communications Commission)-mandated community cable television to engage citizens in matters of community planning and design. Planners are using this medium to reach constituents who tune in to "government television" for information, flock to city hall to share in policy and project debates, and participate in call-in shows.

## ...and planners may loose theirs.

Chances are that what has become a widely accepted and highly beneficial outreach medium for planners may no longer be available once fibre-optics carriers, such as telephone companies, get "into the picture". (Cable uses co-axial technology, though soon to be digitally compressed). In a few years we will - dreadful thought! - be "grazing" over 500 television channels, and quite possibly without any Public Access, Educational or Government channels among them. Understandably, cable-TV companies, their market monopoly jeopardized by other carriers, want to shed the FCC's mandate.

The FCC needs to create an as yet unknown institution to manage the television facilities in question and require all co-axial and fibre-optics carriers to help shoulder the financial burden.

Communities and planners who have come to appreciate government cable access need to remind the FCC of the system's merits and petition the FCC to retain this increasingly valuable outreach medium.



# Santa Clara County's ISTEA Transportation Enhancement Task Force

The Intermodal Surface Transportation Efficiency Act (ISTEA) [HR 2950] was signed into law by President Bush in December of 1991. The primary intent of this act is "...to develop a National Intermodal Transportation System that is economically efficient, environmentally sound, provides the foundation for the Nation to compete in the global economy, and will move people and goods in an energy efficient manner." One of the principal authors of the legislation was local Congressman Norm Mineta.

The ISTEA program has a projected six year funding life (between fiscal years 1992-97) and on overall anticipated nationwide budget of \$155 billion.

One of the components of ISTEA is the Surface Transportation Program (STP), which serves as a new block grant type

of program that may be used by States and local municipalities for improving roads that are not functionally classified as local or rural minor collectors. The total nationwide funding for STP over the next six years is approximately \$23.9 billion.

Ten percent of STP funding must

be directed towards transportation enhancement activities, meaning, "with respect to any project, provision of facilities for pedestrians and bicycles; acquisition of scenic easements, and scenic or historic sites; scenic or historic highway programs; landscaping and other scenic beautification; historic preservation, rehabilitation and operation of historic transportation buildings, structures, or facilities (including historic rail road facilities and canals); preservation of abandoned railway corridors (including the conversion and use thereof for pedestrian or bicycle trails); control and removal of outdoor advertising; archaeological planning and research; and mitigation of water pollution and research of water pollution due to highway runoff."

These enhancement activities must have a direct relationship to the intermodal transportation system. This relationship may be one of function, proximity, or impact. Examples of these components are as follows: "An independent bike path is a functional component of the intermodal transporta-

tion system. Removal of outdoor advertising in the viewshed of a highway is justified in light of its proximity. Retrofitting an existing highway by creation of a wetland to filter runoff from the highway would qualify based on the impact of the highway in terms of water pollution."

As one can begin to see, the implicit purpose of including a transportation enhancements element in ISTEA is to recognize the fact that our highways and transit facilities must blend in with our natural, social, cultural and historic environments, and thus increase the pleasure and satisfaction of their use.

The nationwide transportation enhancements budget over the life of ISTEA is expected to approach \$3.5 billion, of which California is earmarked to receive approximately \$300 million. Of this amount, Santa Clara County could possibly be eligible for up to \$9 million for enhancements monies during the life of the program.

In response to the possibility of utilizing these funds to further historic preservation projects, the Preservation Action Council of San Jose has orchestrated a County-wide task force entitled "Destination Cities" in order to coordinate and prioritize local enhancements proposals. Representatives

> from every city, county, and historic preservation group have been invited to attend monthly meetings that were initiated on June 25 of this year.

> The primary purpose of these efforts has been to educate the various parties involved in what the ISTEA program is all about and to help build a consensus around which proposed enhance-

ment projects will be the most viable to submit for approval by our local Metropolitan Planning Agency (MPO), which in our case is the Metropolitan Transportation Commission (MTC). The MTC has been vested with the authority by the State Department of Transportation (Caltrans) as the final decision making body that will determine how transportation enhancements funds will be allocated in our area.

It is believed that by forming a united coalition of diverse preservation interests throughout Santa Clara County, any enhancements proposal that is finally submitted to the MTC for review will be approved with little opposition.

## WALKING TIME BOMB

We journalists are often called to difficult tasks. Some of us must leap into perilous situations, enter fire zones or cross police barriers. Others become war correspondents or even hostages.

As your correspondent for Northern News, the task fell to me to cross into enemy territory, to subterfuge myself and walk boldly into their very headquarters, complete an espionage sting operation, and try to return alive so that you might know the truth.

And that is why I decided to go to the annual dinner meeting of the Building Industry Association.

Known as "Building Better Communities Night," the BIA bash is a chance for major developers to rub elbows with local politicians and honor their own as they reflect on the building boom or gloom of years gone by and the years ahead. What worried me was the fact that this year's "speaker" was also a stand-up comic. Now who do you think would be the butt of most of the jokes at a homebuilders' convention?

My mission (I decided to accept it) was to attempt to save the honor of our dear profession, sisters and brothers, or, failing that, at least to faithfully transcribe the slander being hurled at city planners while the CEOs of Acme and Ajax Homebuilders guffawed on either side of me, sloshing their Chardonnay all over my notepaper.

I knew things might get a little rough when I noticed that the entree looked a lot like spotted owl.

After the dessert, they gave the usual awards to builders and building inspectors, but when they tried to give an award to a planner (San Jose's Joe Horwedel), an inspector stood up with evidence of illegal additions to Horwedel's house, voiding his permits!

The main speaker, Bob Weider, hailed from my hometown, El Cerrito (which is Spanish for "at least we're not Richmond"). He billed himself as a "writer, humorist, comedian, and walking time bomb," and as I predicted, the first batch of grenades had planners' names on them.

"Why is it that Cities only have Planning Departments? Why don't they having 'Doing Departments'?" I thought the councilwoman in front of me was going to need oxygen after that one.

He then proceeded into a merciless barrage against San Jose Planning Director Gary Schoennauer, who was not in attendance. Low blows included many references to Gary's diminutive stature ("his picture in the newspaper said, 'Photo actual size'"). He also imitated Schoennauer after completion of a project (running down the hall shouting, "De Plan, Boss, De Plan!"). He did acknowledge, however, that the size of Schoennauer's fan club had doubled ("now they can use the diamond lane").

San Jose bashing continued with the assertion that Quality of Life in San Jose was an oxymoron, and, referring to restrictions set by the mayor, he added, "where else in the world do builders get "nailed" by someone named Hammer?"

Other cities took heat, too, notably Oakland ("Half of the city burns up and the other half comes to watch," and "why don't we let the Japanese buy Oakland? We'll have a fire sale.").

This indifference to natural disasters was underscored by his actions after the Loma Prieta quake: With all the bridges and freeways blocked, he immediately called Domino's so he could get a free pizza if it took them longer than 30 minutes. And speaking of bridge blockages, he had advice for the Desert Storm protesters who blocked the Golden Gate: "If you want to call attention to your cause, don't alienate a million commuters. Seize the toll gates and wave everyone through!"

Even our jargon took a beating: "High Density Residential" = Housing for people who are very dense ("Moron Manor") vs. "Single Family Detached" = Houses for people who are indifferent and don't want to know their neighbors. The street-naming brouhaha in Alamo didn't escape his barbs: "They didn't like the name Gay Court, so I guess Flaming Faggot Lane is out of the question."

He noted that those who objected to more housing were also those who objected to homelessness, saying that Bush's 1000 points of light were campfires started by those who have been evicted ("mobile homes are now shopping carts").

He closed with advice for beleaguered builders who have been painted by planners and the media to be "landsharks."

"The answer is simple. Just have landsharks declared an endangered species!"


