ABAG Projections: Long Distance Commuting Will Double

he latest demographic projections for growth in the nine counties of the immediate SF Bay Area were released in mid-December. The 25-year growth forecasts by the Association of Bay Area Governments (ABAG) in their *Projections 2002* report, as usual, contain both good news and bad news. The good news is that the Bay Area will experience strong economic growth over the next 25 years in spite of the implosion of Internet startup companies, and in spite of the short-term economic impacts of the Sept. 11 attacks.

However, the bad news is that the number of working people who will commute into the Bay Area from outside of the region is expected to more than double by 2025, bringing the total number of commuters driving in from the Central Valley and other farflung counties to 300,000. Currently, about 150,000 commuters make the daily trek into the Bay Area, with over half of that number driving over the Altamont Pass on the I-580 freeway from cities in San Joaquin and Stanislaus Counties. The remaining commuters come in from the Sacramento region, or from areas outside Silicon Valley (Santa Cruz, San Benito, and Monterey counties).

ABAG predicts that the volume of trips from the Central Valley is expected to soar by 60% over the next 25 years, and trips from the Sacramento-Yolo County region could jump 71%.

The reason for the anticipated explosion is simple: the Bay Area is expected to generate many more new jobs than new housing units. The result will be more suburban sprawl on the fringes of the region, as adjacent counties provide affordable housing for the new workers who can't find housing where they work. The ABAG numbers paint a grim picture of future generations that are

doomed to live with daily one-way commutes of two hours or more.

The nine-county San Francisco-San Jose region will add about 1.2 million jobs by 2025, many of them either in or associated with high tech. During the same period, the population is expected to jump from 6.8 million to 8.2 million, an increase of 1.4 million residents. Assuming that an average of 1.5 workers reside in each new household, the projected job growth of 1.2 million would require about 800,000 new housing units. But there is not enough available housing planned to provide places to live for all those new workers. And when you factor in the availability of affordable housing that can actually be purchased or rented by the new workers at the wages they are paid, the shortfall becomes that much worse.

To address this great disparity between job and housing growth, ABAG and other agencies are pushing "smart growth," i.e., the revitalization of downtowns and older suburbs, construction of denser housing, with an emphasis on increased public transportation and the preservation of outlying agricultural lands. But smart growth, as laudable as its principles are, can only tinker inconsequentially around the edges of a huge dispersed land use pattern that has been decades in the making.

Even if 50% of all the new projected growth was "smart" (city-centered and dense), the basic footprint of the Northern California landscape could not absorb the amount of new housing that must be built to accommodate the new workers that are projected in the affluent Bay Area economy. Despite our best collective intentions and "smart" planning, the affordable housing program for San Jose will still be located in places like Tracy, Manteca, and Salinas.

What is needed is a much more drastic, even radical, planning approach: we need to meter future job growth in the Silicon Valley and elsewhere to match the anticipated supply of affordable housing within a reasonable commute "shed" (say, a maximum of 35 to 40 miles). This idea has been implemented in other metropolitan areas, such as Portland, where the huge Intel semiconductor plant in the suburbs of Washington County was told: we will accept your planned growth, but if you exceed your projections, you will agree to pay a certain fee for each excess worker, so that we have funds to provide affordable housing and services to mitigate the impacts of rapid job growth.

For all its claims to be on the cutting-edge of all things progressive, maybe the Bay Area can learn a few lessons from other parts of the country that are doing a much better job planning for the future.

National Survey Documents Voices of Rural America

To understand local citizens' current perceptions and priorities about community life in rural areas, the Pew Partnership for Civic Change commissioned a national survey of 1,830 adults. Conducted in October 2000, interview questions were grouped around: community life and participation; key problems facing communities; and community problem solvers. A picture emerges from the survey that both describes current attitudes of rural residents and identifies salient differences and commonalities between urban and rural communities. hen Latah County Commissioner Paul Kimmell became concerned about the loss of farm and ranch land in Latah and other Idaho counties, he turned to American Farmland Trust for help. AFT and an advisory committee that included Kimmell planned five day-long workshops in Idaho to educate commissioners, ranchers, landowners and others about land protection. Representatives from AFT and elsewhere taught them about the variety of land protection techniques and how these techniques are being used most successfully around the country.

"The workshops provided us with an invaluable amount of information about the latest trends in land protection," said Kimmell, who has been a county commissioner since 1999. "Since we now know what works and what doesn't, we are creating a land protection strategy for the county."

Conducting workshops on land protection techniques, the benefits of protected land, land stewardship and estate planning is one of the services offered to counties by AFT. A national nonprofit organization with 20 years of experience protecting agricultural land and working with communities, AFT received a national award in September for its workshops from the Natural Resources Council of America. Other AFT services are:

- Mapping agricultural land: Using geographic information system (GIS) technology, AFT creates maps that identify the agricultural land that is the highest priority for protection and maps that show how much agricultural land could be lost.
- Assessing the cost of community services: Cost of Community Services studies illustrate the positive fiscal contribution of agricultural land.
- Measuring public support for land protection: AFT surveys citizens to find out how they feel about land protection in relation to other local issues and how much they are willing to pay to protect it.
- Profiling the agricultural industry:
 AFT gathers and analyzes economic,
 demographic, land use and other data
 about the agricultural industry and
 agricultural land use policies in a county.

- Developing land protection plans and programs: AFT helps develop a well-rounded land protection plan. AFT helps strategize and implement land protection techniques.
- Delivering the message about land protection: AFT helps a community create and carry out a communications, marketing or outreach strategy for a land use study, easement deal or new farmland protection plan.

AFT has a staff with a wide range of professional and academic backgrounds—farmers, lawyers, appraisers, wildlife biologists, policy experts and land use planners.
