## Going beyond LEED— North America's first "One Planet community"

ADDRESSING CLIMATE CHANGE, PROVIDING JOBS, AND MAKING A FAIR PROFIT

[Ed. Note: I visited the development in July with the California Planning Roundtable. Afterward, I asked our host to write an article for Northern News.]

In Rohnert Park, three miles east of downtown Cotati, a half-dozen outdated factory buildings on a 175-acre site are being converted to uses that will support a "five-minute lifestyle." Dubbed <u>Sonoma Mountain Village</u>, the mixed-use community targets "LEED Platinum for Neighborhood Development." It also follows a detailed plan for how every resident can live within a "one-planet" ecological footprint, using only one's own fair share of resources.

Sonoma Mountain Village expects to reduce greenhouse gasses by 82 percent, vehicle miles traveled by 54 percent, and carbon content of fuel used by 12 percent—all by 2020.

The former factory buildings—totaling 700,000 square feet—are being given a more modern architectural expression aimed at improving the pedestrian experience. With some additions, the buildings will be home to 182,500 square feet of retail and over 100 other businesses; and 1,900 homes will be built to house 5,000 residents. After three years of planning, a development agreement is in place, and an EIR has been prepared. New construction is expected to begin early in 2009, with buildout by 2020.

**History.** Until very recently, the site was the Agilent (formerly H-P) campus in Rohnert Park. About two years ago, Greg Searle, the Executive Director of BioRegional North America, asked Codding Enterprises, the site's new owner and developer, "How

much will your LEED community contribute to greenhouse gas emissions?" Two months of research concluded it would emit 17,000 tons of greenhouse gases annually.

BioRegional North America helped Sonoma Mountain Village go beyond LEED with a comprehensive sustainability plan based on the <u>10 principles of one-planet living</u> as originally created by WWF International. The principles are zero carbon; zero waste; sustainable water; local and sustainable materials; local and sustainable food; sustainable transportation; equity and fair trade; culture and heritage; and health and happiness. Codding and BioRegional will monitor the project for progress against ambitious sustainability targets each year until 2020.



At the heart of Sonoma Mountain Village is a planned urban square framed by 3- to 7-story buildings with street level stores, restaurants, and services

Here are some of the key areas and their metrics:

**Transportation and land use.** Sonoma Mountain Village will provide neighborhood amenities, such as groceries, restaurants, offices, and daycare that residents can walk to in five minutes. Overall housing density will be 17 units per acre—higher at the core, with density decreasing outward.

The careful integration of land uses and density should significantly reduce automobile use. The plan calls for a "jobs to employed residents" ratio slightly greater than 1.0—providing opportunities for residents to work in the community and for workers to be able to live there.

**Food.** Sonoma Mountain Village promotes local and sustainable food production. Grocery stores that have been invited to the community have committed to offering a specific percentage of locally grown food. A farmers market will operate seven days a week. Residents will be able to grow some of their own food at onsite garden plots.

**Construction materials.** Codding has remodeled an existing 50,000 square foot facility to manufacture structural steel framing

for all residential and commercial construction at Sonoma Mountain Village. The onsite plant uses renewable energy and recycles local materials. For example, it takes the equivalent of six SUVs from a local junkyard to frame a 2,000 square foot home. The use of solar energy saves approximately 50 trees compared to conventional manufacturing methods.

**Energy.** All homes will be carbon neutral and will exceed the state's minimum energy performance by 50 percent and obtain all their energy needs from solar and wind by 2020.

Sustainable business. In 2007, Codding formed the first business incubator in the North Bay—the nonprofit <u>Sonoma</u> <u>Mountain Business Cluster</u>—targeted to stimulating good-paying careers for the region. The nonprofit provides coaching, mentoring, networking, and access to capital for sustainable resource and socially relevant technology start-ups. The incubator already has 24 tenants and is 60 percent occupied.

Through continued research, collaboration with elected officials to remove barriers, sharing of information, soliciting opinions and feedback, and documenting of the process, Codding is moving toward its ultimate goal of creating a deeply sustainable mixed-use community built with human needs and emerging technologies in mind.

**The bottom line.** Development is about supporting life. Life is <u>not</u> about <u>no</u> growth. We should ask ourselves, "<u>What</u> do we want to grow?" Sonoma Mountain Village is one replicable model for sustainable development, and it will make a fair profit.

The term of the Administrative Director is two years, commencing January 1, 2009. The term of the Director Elect is two years, commencing January 1, 2009. On January 1, 2011, the Director Elect will become the Northern Section Director for a two-year term.

Candidates for Administrative Director should be available to attend all board meetings (held once every two months) to receive and be held responsible for all records of the Section; conduct the correspondence of the Section under the direction of the Section Director and the Section Board; take and distribute the records of actions resulting from Section Board meetings; and perform such other duties as are customary to the office of Administrative Director consistent with the Section Bylaws.

# Report available on jobs-housing balance

A 16-page illustrated report that summarizes both the objectives to be achieved and the strengths and shortcomings of various methods of calculating and assessing jobs-housing balance is available from the California Planning Roundtable. Aimed at the practitioner, Deconstructing Jobs-Housing Balance (September 2008) focuses on balancing jobs and housing in California communities and regions in which new residential or employment-generating development is proposed. "Working toward jobs-housing balance may be a desirable element of a strategy to reduce peak period congestion, but it is only one of a number of transportation and land use policies and strategies that must be pursued," say the authors. **"For most cities, recession has arrived."** ... [M]easured at the local level, the slowdowns are well under way. According to an analysis by Moody's Economy.com, about two-thirds of the country's 381 metropolitan areas were in recession..." based on "...employment and industrial production data for the six months ending in August..." —*Bill Marsh in The New York Times, Week in Review, Oct. 5, 2008 (click here).* A graphic accompanying the article shows that most of the US cities already in or at risk for recession are east of the Mississippi (although 18 are in California from Los Angeles north through the Central Valley, Sacramento, and including half-a-dozen Bay Area cities). At the same time, the economies of 58 metropolitan areas were still expanding in August. Those included San José and 18 cities in Texas. (Click here to view the graphic.)

**2008 big city sustainability rankings.** Oakland and San Francisco remain among the country's top 10 sustainable cities out of 50 ranked annually by SustainLane.com. San José moved up to 21st, from 23rd in 2006. San Francisco led all cities in its handling of energy and climate change and waste management, was second in planning and land use, but 50th (last) in housing affordability. California cities generally ranked high in percentage of clean energy. Oakland gets 17 percent of its power from renewable energy, including wind generating facilities at Altamont Pass; San Francisco and San José each get 12 percent from clean sources. About a third of the greenhouse gases produced in the United States come from electricity production, with renewable electricity sources producing no greenhouse gas emissions. ## BART extension to Santa Clara County may be closer.

Carl Guardino, President and CEO, <u>Silicon Valley Leadership Group</u>, called our attention to the California Transportation Commission's approval last month of a payment plan for the South Bay BART extension. The payment plan will deliver \$240 million over six years, completing the State's commitment of \$760 million toward the BART extension from Fremont to Milpitas, San José, and Santa Clara. With BART connecting to Caltrain in downtown San José at the HP Arena and in Santa Clara, rapid rail will circle the Bay south of the Bay Bridge.

## Bringing equity into climate change conversations

PolicyLink—a national research and action institute advancing economic and social equity and headquartered in Oakland—has commissioned and published a 40-page report, "Understanding Climate Change: An Equitable Framework," by Serena W. Lin. The paper hopes to "contribute to a deeper understanding of the issues surrounding climate change within the social equity movement" and "inspire leaders to learn not only about climate change but to also bring their knowledge, experience, and alliances to the climate change debates and to help develop equitable solutions."

The report has five chapters:

- The scale of the challenge;
- Why equity advocates should care;
- The relationship between climate change and air pollution;
- Energy production, climate justice, and the climate policy debate; and
- Opportunities and challenges to address climate change and promote equity.

Both BART and Caltrain will connect with all three passenger terminals at San José International Airport via the Santa Clara station.

Local dollars to build the BART extension were approved by Santa Clara County voters in 2000. While State funds are now secured, the federal government wants to make sure the extension can be operated and maintained before committing to the 20 percent still needed to construct the line. If approved, Measure B—the BART initiative on this month's Santa Clara County ballot—will provide the needed operating and maintenance funds. Measure B's 1/8 of one percent sales tax will not start until and unless the federal funds are secured.

## Planning layoffs turn tragic

Petaluma's chief building official, Cliff Kendall, was found dead September 23rd, an apparent suicide. He was among 12 of 23 members of the city's planning department whose positions were cut to help close a multimillion-dollar budget shortfall.

The community development department positions eliminated by the Petaluma City Council September 15 were the chief building official, two building inspectors, two senior planners, two assistant/associate planners, two permit technicians, two office assistants, and a GIS mapping analyst.

As home sales fell over the past year, City revenue from building permits and other development-related fees dropped 60 percent below expectations. The city had not adopted a budget and had been operating with a \$20 million emergency appropriation since July 1. The layoffs saved the city about \$1.1 million. More layoffs in other departments could be coming in the next few months, according to the city manager.

The Council apparently was considering a "golden handshake" and early retirement for employees with at least five years of service when Mr. Kendall took his life—a week after learning he was to be laid off. Mr. Kendall, 55, had worked eight years for the city. The local newspaper reported he was upset about losing his job and worried he would also lose his house.

The Cliff Kendall Memorial Fund has been established at Redwood Credit Union to help Patricia Kendall, wife of the deceased, with expenses in the wake of her husband's death. The city's development department announced it would reduce counter hours and phone access for the public, take longer to complete building inspections, and curtail work on an updated development code, a green building program, and a public art program.
